**EXHIBITORS**

Companies that rent certain exhibition space and pay the registration fee.

The cost of registration fee includes the following services:

- a) Free exhibitor passes
- b) Announcement in the official fair catalogue
- c) Free parking passes

**ALLOCATION OF EXHIBITION SPACE**

The space is considered to be allocated when the organizer sends to the exhibitor an 'A' application for confirmation by email.

The deadline for certification of the exhibitor,s application is 10 days from its receipt; otherwise the organizer retains the right to cancel the allocation of the exhibitors space.

**ADDITIONAL TERMS**

**Opening hours**

The exhibitor agrees to comply with the opening and closing hours of the Fair, and particularly that the stand with all displayed exhibits shall be functional until the Fair closing.

**Project certification**

The contractor of the construction of the exhibitor,s stand is obliged to submit the project of the stand to the organizer. If the project is not certified, the organizer reserves the right not to allow the beginning of the stand construction.

For the verification of the project, i.e. for the period of assembling/disassembling the stand, the exhibitors, i.e. the contractors who build the stand on their behalf, pay a mandatory fee for joint costs. The fee amount on these ground is expressed in the price list.

Insurance for the duration of assembling/disassembling the stand is within the responsibility of the construction contractor stand.

Responsibility for damage caused to property, employees or third parties, should they be uninsured, shall be fully borne by the stand construction contractor.

**Insurance**

The insurance of exhibits and other property and persons is the obligation of the exhibitor. Responsibility for any damage to exhibits and other property of the exhibitor or employees and visitors at the stand, should they be uninsured, shall be fully borne by the exhibitor.

**CONTRACTING AND PAYMENT CONDITIONS**

The exhibitor shall make a payment:

According to the deadlines specified on the proforma invoice or invoice and based on submitted applications i.e. verification of the application, by the organizers.

Payment deadline -

The payment is guaranteed according to the Law on financial transactions of the Republic of Serbia. In case of payment after the contract deadline, the exhibitor shall pay the interest according to the official published default interest rate.

The exhibitor may withdraw the submitted application for participation within 5 days from the date of its submission.

If the submitted application for participation is withdrawn after the aforementioned deadline, the exhibitor is obliged to pay the entire contracted amount.

The organizer is entitled to rent the canceled venue without any compensation towards the exhibitor in the event of withdrawal of application or should he fail to make the full payment within the prescribed timeframe.

**Cancellation by organiser / force majeure**

If the Venue become impossible to hold the Manifestation for reasons beyond the control of the Organiser, Organiser reserves the right to change the location and/or date of the Manifestation.

**The application for participation has the legal force of a contract.**

Contracting parties have agreed to settle any disputes arising from this contract at the competent court in Belgrade, Serbia.
